## <u>Abstract</u>

The activities in WP2 aim to build comfort and consensus on the legal framework and the governance structure of KM3NeT with the assumption that the legal entity will be an European Research Infraststructure Consortium (ERIC). In this document the approach taken by WP2 is described. The activities deviate from the original D2.2 description in the Grant Agreement in that we have not obtained permission to make public minutes of meetings with the ministeries. In this document, we report openly on the progress and activities of the ERIC working group and the results towards the final deliverable of WP2, i.e. to develop the draft Statutes and to guide the request to the European Commission (EC) to establish an ERIC.

# VI. PROJECT SUMMARY

KM3NeT is a large Research Infrastructure that will consist of a network of deep-sea neutrino telescopes in the Mediterranean Sea with user ports for earth and sea sciences. Following the appearance of KM3NeT on the ESFRI roadmap 2016 and in line with the recommendations of the Assessment Expert Group in 2013, the KM3NeT-INFRADEV project addresses the Coordination and Support Actions (CSA) to prepare a legal entity for KM3NeT, thereby providing a sustainable solution for the operation of the Research Infrastructure during ten (or more) years. The project is carried out within the context of the current KM3NeT Collaboration which already has a provisional implementation of the management and governance of the Research Infrastructure in place.

# VII. EXECUTIVE SUMMARY

The primary objective of work package 2 is to establish a legal entity for the KM3NeT 2.0. Research Infrastructure. The preferred implementation is that of an European Research Infrastructure Consortium (ERIC), with its seat in the Netherlands at the Amsterdam Science Park. The activities in this work package cover networking and legal tasks to establish a KM3NeT legal entity.

This document is a report on the approach taken to establish an ERIC working group (EWG) where the Ministries and the science community are brought together. The ERIC working group establishes a forum of representatives of the political authorities and the KM3NeT Collaboration, where steps towards the ERIC are discussed and proposed solutions formulated.

Based on experience with other ERICs and growing insight, it was decided to amend the deliverable D2.2. to a report on the approach taken to connect the KM3NeT project with the Ministries, instead of the original deliverable to produce the minutes of the meetings with the European Commission and the Dutch Ministry. This decision was made right at the start of the INFRADEV project.

The implementation of an ERIC legal framework is regulated by European Law. According to the EU Regulation, the ERIC is to be established by the European Commission on request of at least three EU Member States. The ERIC legal framework would provide the KM3NeT project with high and long-term visibility, support and robustness.

For this reason, the KM3NeT ERIC working group, comprising representatives of the ministries and the KM3NeT Collaboration, was set up in June 2017. A few months later its legal support team was set up after a call on the EWG members to nominate a legal experts. The objective of this ERIC working group is to agree on a sustainable governance structure of an ERIC legal entity for KM3NeT and to submit an application for the establishment of a KM3NeT ERIC. The legal support team provides advice on legal topics and arising issues. The activities of the KM3NeT ERIC working group and its legal support team are explained in more detail in chapter 2.

After the EWG's first meeting the EWG realised that it was essential to ensure an effective communication link with the main bodies in the KM3NeT project. The representatives of these KM3NeT bodies have received a standing invitation to the EWG meetings.

At this moment, the discussions in the EWG are heading towards consensus on the governance structure of the ERIC. Following the consensus in the EWG on all the documents for submission, an opportunity will be provided to join the formal ERIC-request for other Member states/Ministries. We are confident to initiate the (informal) request to the EC, but our timeline for the formal request is critical.

# 1. Introduction

The primary objective of work package 2 is to establish a legal entity for the KM3NeT 2.0. Research Infrastructure. The preferred implementation is that of an ERIC, European Research Infrastructure Consortium, with its seat in the Netherlands at the Amsterdam Science Park. The activities in this work package cover networking activities and legal tasks to establish a KM3NeT legal entity.

This document is a report on the approach taken in the networking activity by establishing an ERIC working group comprising representatives of the ministries and the KM3NeT Collaboration.

For a better understanding of the process, the parties are introduced:

#### KM3NeT

KM3NeT is a research infrastructure (RI) under construction in the Mediterranean See. The KM3NeT RI is listed in the ESFRI roadmap in 2016.

### KM3NeT project

The project to design and construct the initial phase of the KM3NeT Research infrastructure (RI). The initial phase 1 has been completed and the MoU for phase 2 towards KM3NeT 2.0 will be developed.

### KM3NeT – INFRADEV

The current H2020 coordination and support action aims to support the transition to a longterm, sustainable governance and legal entity for the KM3NeT RI.

### KM3NeT Collaboration

The KM3NeT Collaboration is the scientific community of the researchers and institutes that work together under an MoU to develop, construct and operate KM3NeT.

In this report, the following terminology will be used: KM3NeT for the RI, and KM3NeT Collaboration for the group of organisations behind the KM3NeT project.

The task related to deliverable D2.2. is described in the Grant Agreement as networking activities for setting up an ERIC:

"First, this consortium will contact the Dutch Ministry of OCW in order to appoint a Dutch coordinator who will represent the Netherlands on behalf of KM3NeT. This coordinator will interact with the European Commission and the Resources Review Board (RRB) of KM3NeT to establish contacts at ministerial level. National coordinators will be appointed who talk to the research council and the ministry on behalf of KM3NeT.

A sequence of meetings will be organised to prepare the statutes of the envisaged ERIC. This list of countries to start this process will include France, Italy, Spain, Greece, Germany and the Netherlands. After the necessary input has been gathered, the next step will be to approach other countries."

The ERIC working group is charged to shape the transition from the current to the future KM3NeT governance.

#### Current KM3NeT Collaboration

The current KM3NeT MoU describes the governance and finances of the KM3NeT project. The high-level governance bodies in the KM3NeT MoU are:

- Resources Review Board (RRB), tasked with the supervision of the KM3NeT project (expenditure of the budget)
- Institutes Board (IB), elects the management, decides on membership applications, prepares financial and strategic plans and ensures the commitment of the institutes for the work plan
- Management Team (MT) (headed by a spokesperson) tasked with the execution of the KM3NeT project, leading the construction and development process of the KM3NeT infrastructure.

### Framework for the implementation of an ERIC

The ERIC legal framework is regulated under European Law. The following link refers to the EU ERIC Regulation - <a href="https://ec.europa.eu/research/infrastructures/pdf/council\_regulation\_eric.pdf">https://ec.europa.eu/research/infrastructures/pdf/council\_regulation\_eric.pdf</a>. Below the ERIC's basics are introduced:

- The ERIC is a legal entity specifically designed for European research infrastructures.
- An ERIC is established by the EC on request of at least 3 EU Member states. It is assessed by the EC
  on the criteria of the financial viability, scientific added value to the European Research Area and
  an effective governance structure.
- An ERIC is a vehicle providing a robust and sustainable governance for the long-term operations of the KM3NeT infrastructure.
- The high level governance bodies in the ERIC-framework are the
  - Council working on high-level policy and strategy
  - Director General whose tasks are the day to day operations
  - Support office and a management committee, tasked with supporting the director in his executive duties.

The challenge in the transition to the KM3NeT ERIC is to transfer all responsibilities from the current structure of the KM3NeT project (MoU) to the new ERIC structure. The current KM3NeT MoU, phase 1 has now expired while the MoU for phase 2 has not been decided yet. That makes the starting position for a transition to a KM3NeT ERIC diffuse. Nevertheless, delays in the ongoing construction of the KM3NeT RI should be prevented.

We identified several issues that are challenging the transition towards the long-term governance. We address them one by one to smooth the path for the ERIC. Given the experience in the development of other ERICs, it takes effort and time to first collect all the necessary information and then present this information convincingly to all stakeholders.

Obvious challenges in this transition process are: constraints related to the regional and structural funding, an ongoing construction process, 90% in-kind contributions, 45 institutes represented in the Institutes Board, each contributing to the construction (originating from 12 nationalities). Not all institutes well have ministerial representatives in a future ERIC Council, which is perceived as a major difficulty. There might be other as yet unidentified challenges that will appear and need to be dealt with later.





# 2. Plan

The plan for the work package is to reach consensus on the ERIC governance structure, draft the ERIC statutes, and submit a request and establish KM3NeT ERIC statutes as a final output in project month 36 of the INFRADEV project. Below the actions so far are described.

The formal documents, which were provided to our Work package, were clear about the transition of the current governance to an ERIC legal framework. Both the current KM3NeT MoU and the Grant Agreement stated that the KM3NeT project was ready to transit to an ERIC entity.

Based on experience with other ERICs, we have started by connecting the scientific partners and the Ministries of the lead funding agencies of the Grant Agreement.

The approach taken was to first involve the six countries that committed to the KM3NeT – INFRADEV project, in a dedicated ERIC Working Group (EWG). The Ministries of France, Italy, Spain, Greece and Germany were invited by the Dutch Ministry to participate in the EWG. Unfortunately the German Ministry was not able to join due to internal policies towards participation in ERICs. In order to guide the delicate transition process well, the EWG has been composed of ministry representatives and national KM3NeT representatives from the five countries. The EWG is chaired by a former ESFRI chair and the secretary has a legal background. Both have experience with other ERICs.

During the EWG's first meeting it became clear that there was no sufficient level of common understanding and awareness in the Collaboration about the upcoming transition process.

The scientific organisations participating in the EWG had at that time not a common position on keyissues such as: the perimeter of the ERIC; the best governance structure for this ERIC; the interactions between the ERIC and the national organisations responsible for the infrastructure on the site locations; a common financial fund. Therefore the EWG has invited the various bodies in the KM3NeT project to formulate common positions on the key issues.

After the second EWG meeting the legal support Team (LST) was established and is invited to the EWG meetings. The LST members are legal experts from the various countries involved, as expertise on national legal systems and regulations is required. The LST has the objective to support the EWG and provide advice on legal issues. It is chaired by the WP2 work package leader/ EWG's secretary.

### **EWG and LST activities**

In the next paragraph the activities in WP2 are described and the progress since the start documented. The WP activities involve EWG and LST but also the WP2 session in the joint meeting of the KM3NeT-INFRADEV project and the KM3NeT Collaboration in June 2018. The conclusion at the end of the paragraph provides some reflective thoughts.

EWG: Leadership

It is the EWG's opinion that it could be disruptive to communicate preliminary discussions or draft documents before the EWG has reached consensus among themselves. It was therefore important to establish solid communication links with the bodies in the KM3Net Collaboration, so that other KM3NeT participants feel represented and informed by their KM3NeT representatives. (Annex 2, table 1)





## EWG: building consensus

The first EWG meeting was organised with the understanding that the transition to an ERIC governance structure was broadly supported within the Km3NeT Collaboration. Without consensus on the keyelements (see above), it is not possible to develop a governance structure.

The EWG requested additional information and position statements from the bodies in the Collaboration on key topics for the governance structure: perimeter of the KM3Net ERIC; governance structure (how to transit from the current bodies); business plan and the financial schedule. One of the critical elements in these discussions was the origin of the funding resources and the relating conditions and constraints.

The draft ERIC Statutes are now taking shape and may be finalised mid-2019. However, according to the ERIC guidelines, the Statutes should have a financial annex and a technical annex. The submission of an ERIC request depends of course on the progress in the discussions in the EWG about the topics of a sustainable funding scheme and the development of other legal arrangements for the Sea Floor Network and detector units. The progress until now may seem small but once the comfort and trust around key issues is built the process will certainly speed up.

### EWG: Meetings

The EWG has met 5 times since the start of the Project: the first meeting was in June 2017 in The Hague; the 2<sup>nd</sup> meeting was hosted in Paris in October 2017; the 3<sup>rd</sup> meeting took place March 2018 in Rome; the 4<sup>th</sup> meeting was held in July 2018 in Amsterdam; the 5<sup>th</sup> meeting took place in November 2018 in Rome; the 6<sup>th</sup> meeting is scheduled for March 2019 in Paris.

**ANNEX 1** provides the agendas of the EWG meetings, giving an impression of the variety and progress on the topics of the discussions.

Annex 2 provides an overview of the participants in the EWG meetings: members EWG; members LST; spokesperson KM3NeT; representatives of the KM3NeT Collaboration (RRB and IB).

### Legal Support team: legal support

The EWG asked the EWG-secretary for legal advice and nominated legal experts for the establishment of a legal support team. The secretary is leading the legal support team with currently legal experts from France and Italy and a technical engineer from Italy. This proves to be a fruitful mix of expertise.

### LST: assignments by the EWG

The first issue assigned to this team was to explore and analyse constraints related to regional and structural funding in Italy and France. The majority of the project on both sites is funded by these regional or structural funds. Therefore it was necessary to investigate whether these constraints would have an impact on the governance and if so, how it could be legally bypassed.

The second request for the LST was to investigate and develop a service level agreement (SLA) for the two sea-floor networks, being critical components in the KM3NeT RI. The purpose of this SLA is to guarantee the unhindered use of all components for the KM3NeT ERIC. Regarding this request, the support of the technical engineers from each site is crucial for the LST in developing the SLA, as only they have knowledge and skills about technical requirements, site situation, future operations and so on. The development of a draft SLA will be a combined effort from the LST and the KM3NeT management and site engineers.

## LST: meetings

The LST had 5 video/teleconferences and three face-to-face meetings in the period November 2017-July 2018. Our first face-to-face meeting coincided with the ERIC Forum in Oxford. We also had a oneday face-to-face meeting in Paris and we met adjacent with the 4<sup>th</sup> EWG meeting.

At this moment, the LST is scheduling a range of meetings to develop a draft SLA for the Seafloor network. The EWG requires annexing a draft SLA to the ERIC statutes. In this way, the members of the ERIC will be provided with detailed knowledge on the governance arrangement for a critical component of the KM3NeT infrastructure.

## WP2 session in the Joint meeting Collaboration/KM3NeT-INFRADEV, 21-22 June 2018

The work package leader organised and prepared a series of calls to collect input and discuss the topic with the keynote speakers, KM3NeT MT and the project coordinator.

The WP2 session resulted in an intense and fruitful panel discussion on the KM3NeT ERIC governance. The panel was formed by a unique combination of leading persons in KM3NeT: the Chair of the Institutes Board; the Chair of the RRB (Resources Review Board); the Spokesperson and Chair of the Management Team of KM3NeT. They held an introductive keynote speech on various aspects of the governance in a KM3NeT ERIC. The panel discussion definitely resulted in a lot of awareness and understanding of the ERIC framework, bringing the developments within KM3NeT to a new level. In order to be a long-term sustainable research infrastructure, it is important to strengthen the central management and establish a tailor-made legal entity.

### **Deviations of the Plan**

The process and projected timeline were adjusted.

Adjustments in the process

- D2.2. was amended in a report on the progress of the ERIC Working group activities: "Connecting the KM3NeT project with the Ministries".
- Exploration of service level agreements and in-kind contribution agreements was necessary to enable the bonding of critical components of the KM3NeT infrastructure into the KM3NeT ERIC governance.

Projected timeline is critical, this is caused by the

- Timeliness of information provided by the KM3NeT bodies to the ERIC working group
- Development of additional legal arrangements connected to the KM3NeT ERIC.

### *Impact on the deliverables*

The start of the work package was hindered by a lack of common understanding in the KM3NeT project about the perimeter and the road towards the KM3NeT ERIC. Currently, the process is speeding up and discussions in the EWG are heading towards consensus on the key elements of the ERIC.

The bodies of the Collaboration are now better aware of their responsibilities in this process and also more aligned with the activities of the EWG. The support in the rest of the Collaboration for the transition to a new governance structure is building up.

In the final year of the work package, the EWG focuses on the finalisation of the draft statutes and the outline of a solid financial schedule for the initial 5 years, as well as on the other documents necessary for the application of ERIC status. Regarding the financial schedule, the EWG requires also a forecast for the long-term operation of the KM3NeT infrastructure. There is confidence to finalise the required documentation for submission and initiate an informal request to the EC. However, the timeline is critical - taking the developments into account, it is not realistic to expect that completion of the formal request will match the projected timeline.

# 3. Best practice/Lessons learned

#### **Best practice**

In this paragraph describes the best practice to work towards the establishment of an ERIC according to the experience in the work package.

It has been proven to be very efficient to connect the Ministries and the Project right at the start: the Ministries are experienced decision makers in the ERIC procedures. In that sense, their guidance in the discussions with the scientific community and their ERIC network is of great value to the process.

When embarking on national legal complications, a dedicated legal support team was set up comprising of national legal experts. They can easily access the national authorities, the laboratories and the national regulations on site.

### **Lesson learned**

- Make clear that the Ministries are in the lead to decide on the ERIC governance structure.
- Include a Legal Support Team with national legal experts to advise on legal matters on a national level
- Emphasize the responsibility of the science delegates in the EWG for the communication to their communities.

# 4. Next steps

The next steps for the final year will be to continue the discussions and aim for the submission of an application of a KM3NeT ERIC.

The completion of the draft Statutes is expected by mid-2019.

It is expected that the required annexes to the Statutes such as the Financial schedule, the scientific and technical description and the service level agreement for the sea floor network will also be in a sufficient shape by mid-2019. The discussion on these documents has priority on the agenda of the next meeting of the ERIC working group in March 2019.

The opportunity for other Member States to join the ERIC application will be provided after the consensus is reached within the EWG on all the documents required for the application of ERIC status. As soon as it seems feasible to submit an informal request for a KM3NeT ERIC, this process will be initiated.

The table below shows our aims, activities and dependencies for the final year in WP 2.

# 5. Conclusion

At the start of this work package, we encountered some unexpected challenges such as the lack of consensus among the participating scientific organisations in the EWG on a number of key-issues for an ERIC. For this reason the discussions in the EWG took more time than expected, also due to the response time of KM3NeT bodies to EWG requests. At this moment, however, we are well underway and speeding up towards full consensus on the governance structure and the related key issues.

In the coming year of WP2, the activities will focus on the finalisation of the draft governance structure and the draft service level agreements. The KM3NeT project is requested to provide the input for the necessary annexes for the draft ERIC statutes: the outline of a solid financial schedule and the other necessary documents for the ERIC application.

As explained in chapter 2 and laid out in the table in chapter 4, the timeline of work package 2 is critical. Therefore, interaction with the Collaboration (via the KM3NeT bodies) will be intensified by WP2. Another challenge is involving all research institutes beyond the current group of potential KM3NeT ERIC members. The chair of the IB and the spokesperson will encourage the KM3NeT member institutes to present the KM3NeT case to their ministries.

The path towards a KM3NeT ERIC is complex but feasible. We are confident to reach the main part of our deliverables by finalising the draft Statutes, the draft Service Level Agreement and further the required documentation for submission and initiating an informal request to the EC by the end of the final year. However, our timeline is critical – taking the developments in account, it is not realistic to expect that completion of the formal request will match the projected INFRADEV timeline.




